Conduct a public workshop to review and provide comments on a conceptual site plan and architecture for 32, three story, attached, for-sale homes on a 1.97 acre paved site currently used for RV and boat storage on the easterly side of Landing Court opposite a Public Storage facility. Three home types are proposed ranging in size from 1,765sf to 2,274sf. Each home includes a one or two car garage; 27 surface parking spaces are also proposed for a total of 84 on-site spaces.
