**3. C Street Village (HG)  
P2018-082; Design Review Workshop  
APN 157-980-05; 970 C Street**

Conduct a design workshop to review the site design, building massing, and conceptual architecture and landscaping proposed for C Street Village: Development of a 2.68 acre parcel with a co-housing project including 38 homes comprised of 32 two-story condominiums and flats ranging from two- to four-bedrooms (840 to 1,818 square feet) and six one-bedroom (669 square feet) flats over parking, two 484 square foot storage buildings over parking, and a 3,738 square foot, two-story club house.
