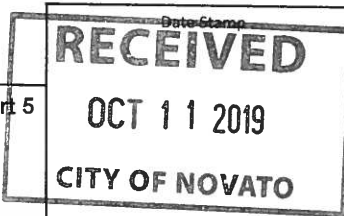

5. Termination Requirements
