

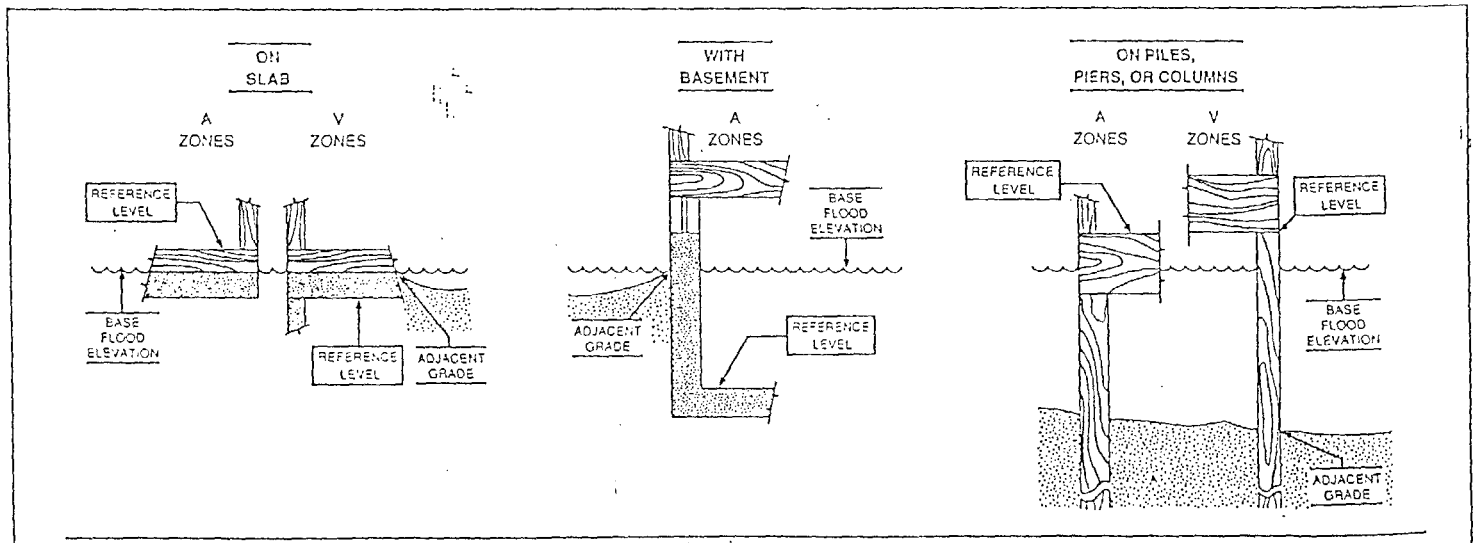

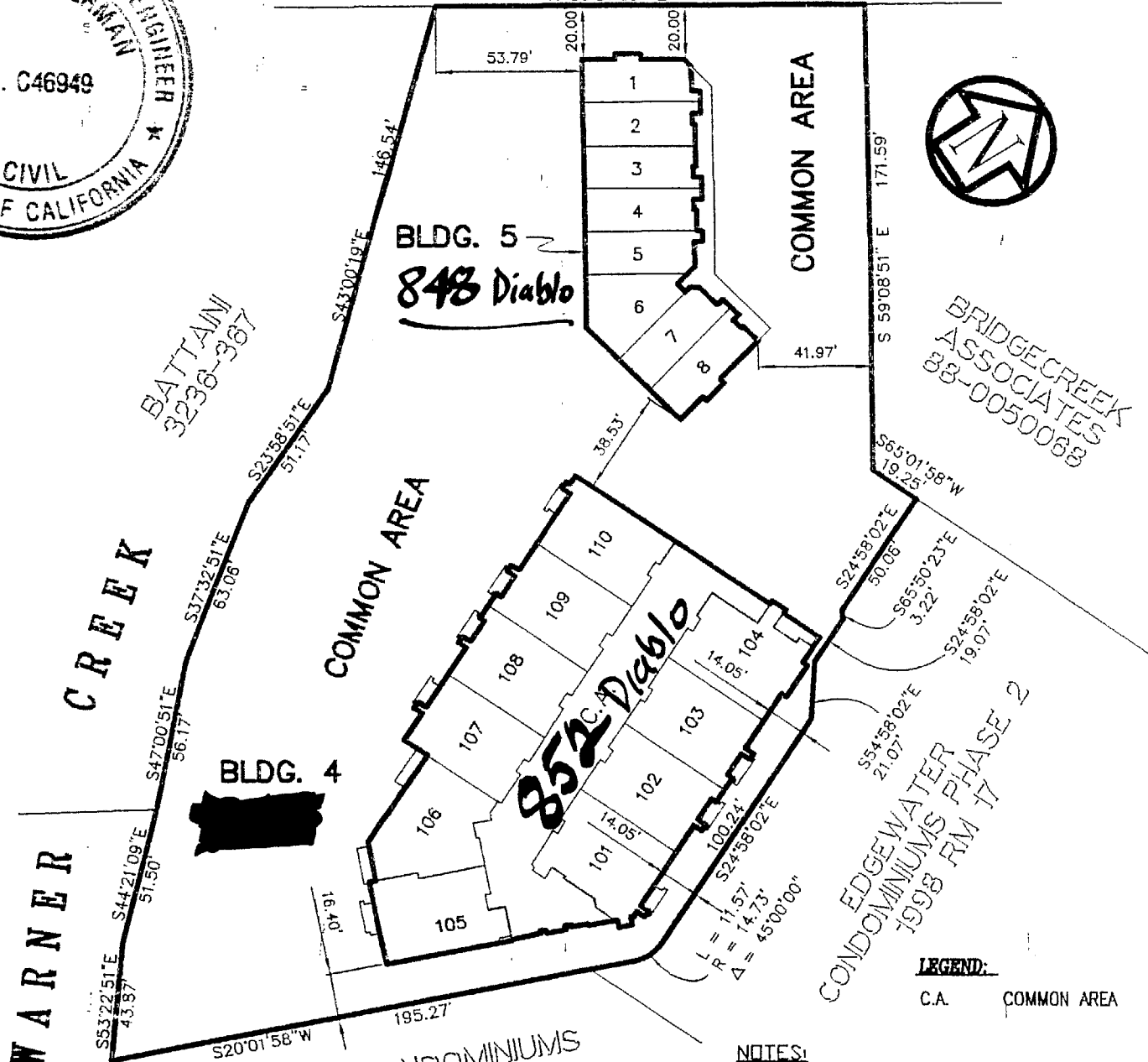
The diagrams above illustrate the points at which the elevations should be measured in A Zones and V Zones.
