## **DECLARATION OF JEFFREY WALTER**

## I, JEFFREY WALTER, declare as follows:

- 1. I am an attorney licensed to practice law in the State of California and before this Court. I am a Shareholder of the law firm of Colantuono, Highsmith & Whatley, PC, attorneys of record for City of Novato. I am the City Attorney for the City of Novato, a position I have held since 1993. I have personal knowledge of the matters set forth herein and if called upon as a witness, I could competently testify thereto.
- 2. On July 14, 2021, at 5:09 p.m. I was electronically served with several declarations in support of an Amended Ex Parte Application and Complaint for Injunctive Relief and Declaratory Judgment in the instant case bearing the letterhead of Anthony Prince, counsel for Plaintiffs. The electronic service message was missing documents, so I called Mr. Prince to request copies of the omitted documents. During that phone call, Mr. Prince did not inform me that he intended to seek a temporary restraining order on July 15, 2021, the following day. He later emailed me the Amended Ex Parte Application and Complaint for Injunctive Relief and Declaratory Judgment he had purportedly filed with the court, but, again, his email to me to which he attached the Complaint did not include any indication that he was intending to apply for a temporary restraining order the following day.
- 3. In the afternoon of July 15, 2021, Mr. Prince called me to inquire whether the Amended Ex Parte Application and Complaint for Injunctive Relief and Declaratory Judgment and supporting declarations somebody had dropped off at the first floor of the administration building of the City Hall in Novato, California, would be accepted as personal service of those papers by the City. I told him that his papers had not been served on the City Clerk as they needed to be, but I would consult with the City Clerk to determine whether the City would deem such service adequate service under the law. During that phone call, too, Mr. Prince failed to inform me that

he intended to seek a temporary restraining order that day.

- 4. On July 15, 2021, at around 5:00 p.m. I left my office to attend an evening engagement I had arranged several months prior. I did not access my law firm email address until the following morning on July 16, 2021, at which time I accessed my law firm email address and learned for the first time that the Court had issued its temporary restraining order ("TRO") the night before.
- 5. In the Court's TRO it is stated that Plaintiffs' proof of service indicates that on July 14, 2021, City Manager, Adam McGill, Mayor Pat Eklund, Mayor Pro Tempore, Eric Lucan, Chief of Police Matthew McCaffery, Public Works Director Chris Blunk and I were electronically and personally served. Neither I nor any of these individuals were personally served with the Complaint and other papers filed in this case and only City Manager Adam McGill and I were served electronically. Indeed, Public Works Director Chris Blunk was not even in the State on July 14, 2021, for he was, has been, and is still vacationing in South Carolina with his family.
- 6. I have not been provided any evidence that a bond has been posted by Plaintiffs which is required under FRCP section 65(c) prior to the issuance of any TRO.
- 7. The TRO restrains the City from "closing Camp Compassion at Lee Gerner Park or otherwise removing those encamped therein." The City has entered into an agreement with Homeward Bound of Marin to offer 15 individuals immediate placement into Homeward Bound's New Beginnings Center. Out of an excess of caution, because the language in the TRO broadly forbids "removing" persons from the park, the City is currently refraining from offering placement at Homeward Bound's New Beginnings Center to any person currently camping in Lee Gerner Park to avoid violating the TRO.
- 8. On July 16, 2021, I received a letter from Mr. Prince regarding a press release issued by the City of Novato in response to the TRO. In that letter, Mr. Prince states "[t]he TRO does not restrain the city from otherwise offering or an unhoused

person from accepting any form of assistance, including appropriate relocation to alternative appropriate housing." A true and correct copy of the July 16, 2021 letter is attached hereto as Exhibit 8.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct.

Re: City's Press Release re Issuance of the Temporary Restraining Order in Marin County Local of the California Homeless Union, et al v. City of Novato, et al.

Dear City Attorney Walter:

Today I became aware of a press release issued by the City of Novato and still posted on the City's official website, which contains demonstrably false and misleading statements regarding the Temporary Restraining Order issued yesterday in this case. Attached hereto is a true and correct copy of the press release in question. The headline of the press release alone is a falsehood, proclaiming as it does, "Federal Temporary Restraining Order Delays Immediate Housing and Support Services to Novato's Unhoused."

As is clear from the plain language of the TRO and as you admitted in our telephone conversation of this afternoon, there is nothing in the TRO that prevents the city from providing housing per the agreement with Homeward Bound of Marin to *any* unhoused person in the City of Novato either camped within Camp Compassion or to any member of Novato's homeless population, the vast majority of whom do not reside in Lee Gerner Park. A true and correct copy of the Order Granting Application for Temporary Restraining Order is also attached hereto.

Furthermore, any claim by the City that the TRO ties the City's hands by enjoining "removal" of plaintiffs from Lee Gerner Park disregards that the term "removal" cannot be reasonably interpreted to mean anything in this case except *forced* removal by way of the challenged ordinances. The TRO does not restrain the city from otherwise offering or an unhoused person from accepting any form of assistance, including appropriate relocation to alternative appropriate housing.

To claim that but-for the TRO, the City of Novato "was prepared to deliver much needed services" suggests that the TRO affirmatively prevents the city from providing such assistance. We challenge you to identify with particularity that portion of the Order that imposes such a restraint.

In short, today's press release appears to be a politically motivated attempt by your client to falsely blame the Court for the city's own decision to withhold the very limited assistance that is now available to the homeless. To cynically use Judge Yvonne Gonzalez Rogers's ruling to suggest that the city and Novato-based nonprofit Homeward Bound cannot go forward with their agreement is an unfortunate deception. The city's public website should not be a soapbox for the Defendants in this case.

In any case, we insist that the City immediately remove the post at issue and refrain from any further attempts at partisan and misleading statements regarding this matter. To the extent that Defendant City of Novato continues to do so, we will hold it fully responsible for any adverse consequences arising therefrom.

# Federal Temporary Restraining Order Delays Immediate Housing and Support Services to Novato's Unhoused

Post Date: 07/16/2021 11:02 AM

<u>Subsequent to the City's news release on July 15, 2021</u> announcing Council action taken on July 13, 2021 to enter into an agreement with Novato-based nonprofit Homeward Bound of Marin for immediate housing and support services for Novato's homeless, a <u>federal lawsuit was filed against the City</u> by the California Homeless Union and several occupants of the encampment at Lee Gerner Park. The lawsuit seeks to prohibit enforcement of <u>new City ordinances 1669 and 1670</u>. Though the City was prepared to enforce these ordinances and simultaneously deliver much needed services, this lawsuit and <u>the temporary restraining order</u> will delay those actions until the Court fully considers this matter. The City is studying the legal filing and intends to respond in support of the ordinances and the immediate housing plan approved Tuesday night.

Utilizing one-time federal American Rescue Plan stimulus monies, these new comprehensive support services would provide housing, food, case management, medical coordination, job placement and training, and support toward permanent supportive housing referrals for up to 15 homeless individuals in Novato, with priority given to those currently residing at Lee Gerner Park and other city encampments.

"The city is disappointed to learn that some occupants of Lee Gerner Park have taken this step that will delay the very services they demand - immediate and safe housing - that would have included substantial support services," said City Manager Adam McGill. "The City went to great lengths to develop a thoughtful plan for this issue that would have met the concerns expressed by the occupants of Lee Gerner Park, considered COVID precautions, and complied with federal law, all of which would have been a win-win for the homeless and the restoration of Lee Gerner Park. We are confident the City will prevail and ultimately be able to help those that truly need and desire these vital services."

Plaintiffs Marin County Local of the California Homeless Union, Jason Sarris, Carrie Healon, Zach Boulware, Lea Deangelo, Donald Hobbs, Lisa Johnson, Bethany Allen, ("Plaintiffs") have filed their Amended Ex Parte Application and Complaint for Injunctive Relief And A Declaratory Judgment, and supporting documents. (Dkt. Nos. 1, 3.)

The proof of service attached to Docket No. 1-1 indicates that counsel Jeffrey A. Walter, for defendants City Of Novato; City Manager, Adam McGill; Mayor Pat Eklund; Mayor Pro Tem Eric Lucan; Chief of Police Mathew McCaffrey; and Public Works Director Chris Blunk ("Defendants"), was served by electronic transmission and personal service on July 14, 2021. No response has been filed by Defendants as of the time of this Order.

## IT IS FURTHER ORDERED THAT,

- 1. Plaintiffs shall serve this Temporary Restraining Order and Order to Show Cause on Defendants no later than 5:00 p.m. on July 16, 2021, by personal service. Proof of such service and signed copies of all declarations in support of the preliminary injunctions shall be filed no later than 9:00 a.m. on Monday, July 19, 2021.
- Any opposition to the Order to Show Cause shall be filed no later than Tuesday, July 20, 2021.
  - 3. Any written reply shall be filed no later than Friday, July 23, 2021 at 12:00 noon.
- Hearing on the Order to Show Cause for Preliminary Injunction shall be held on at 1:30
  p.m. on Wednesday July 28, 2021 via the Zoom videoconference platform.

The Court will entertain a modified schedule for briefing and hearing, and extension of the temporary restraining order, if presented by stipulation of the parties.
